Warm greetings from the ASCHP Executive Board.

As we approach the midpoint of the year, we would like to take this opportunity to communicate several important updates to all members. The following items require your attention and action where applicable:

1. Use of the Term 'Designated' Rather than 'Listed'

Following a series of internal meetings and careful deliberation by the ASCHP executive, it has been officially decided that all registered members shall henceforth refer to themselves as 'designated' with the ASCHP, rather than using the term 'listed'. This terminology more accurately reflects the professional standing of our members and aligns with the language adopted by other credible professional bodies.

This decision was reached after numerous comments and feedback received via Facebook and direct email correspondence, particularly following the previous change from 'registered' to 'listed'. It became evident that 'designated' is a more suitable and professional term that retains both credibility and clarity in the public domain.

Members are therefore requested to update all professional documentation, correspondence, promotional materials, social media platforms, websites, and email signatures to reflect this change with immediate effect. 2. Annual CPD Compliance: Urgent Reminder

We would like to remind all members of their obligation to complete their annual Continuing Professional Development (CPD) activities by the end of the calendar year. CPD is not only a regulatory requirement but an ethical responsibility that ensures professional competence and ongoing development in the field of wellness counselling.
